Our Annual Improvement Plan for 2016-2017 identifies 12 improvement objectives which are aligned to our strategic priorities. We believe these objectives will improve safety, whilst delivering excellent services, which meet the risks and needs of our communities.

Both documents were widely circulated and promoted during a period of public consultation between 5 October 2015 and 11 December
